What legal work is required?

A conveyancer has to check the same information as a purchase. This includes the following:

- Title recorded with Land Registry
- · Any alterations which require planning and building control requirements
- Environmental screening
- · Property connected to mains water and sewerage
- Local Authority Search to confirm the property abuts a public highway, no financial charges or compulsory purchase order
- Redeeming the existing mortgage
- · Checking any special conditions in the new mortgage offer

Grant Saw Solicitors are on the panel for most mortgage lenders and where the client instructs us at the same time as processing their mortgage, we are able to complete the remortgage quickly after the mortgage offer has been issued.

A lot of lenders offer a contribution towards legal costs.

Where there is a Property Log Book and it has been maintained, this will assist us in dealing with the matter quickly. It is important to ensure that planning and building control information is maintained in the Property Log Book and you should ensure that people who are carrying out work to your property are registering the required compliance certificates with the Local Authority and these are provided to you. If you don't have a Property Log Book for your property then please ensure you retain compliance certificates safely.

We can also deal with a transfer of the property at the same time as a remortgage.
